The timetable for Warwickshire's appeals is included below, together with some general information about the appeals process.

**Appeals for Year 7 entry from September 2024**

- National Secondary Offer Day – Friday 1 March 2024.
- Deadline for lodging appeals – Thursday 11 April 2024.
- Appeals received by Thursday 11 April 2024 will be heard by Thursday 13 June 2024.
- Appeals received after Thursday 11 April 2024 will be heard within 40 school days of the deadline date or within 30 school days of the appeal being lodged (whichever is later).

Secondary School on-time applicants: hearings will commence on Monday 29 April 2024 and finish on Thursday 13 June 2024.

**Appeals for Sixth Form places from September 2024**

- Where the offer of a place is conditional upon exam results, appeals should be lodged by Friday 6 September 2024 and will be heard within 30 school days of confirmation of those results, ie by Tuesday 15 October 2024. Whilst appeals can be lodged within 20 school days of confirmation of results, we would strongly advise you to lodge your appeal by Friday 6 September 2024 in order to ensure that your appeal is heard as quickly as possible.
- Where the offer of a place is not conditional upon exam results, appeals will be heard within 40 school days of the deadline for lodging appeals, ie by Wednesday 4 December 2024.
- Please contact the school directly for information regarding individual sixth form arrangements.

## **In Year Admissions (outside of the normal round of entry)**

- In year (or casual) admission appeals will be heard within 30 school days of the appeal being lodged.
- Where possible, all appeals received by Tuesday 25 June 2024 will be heard before the start of the new term in September 2024. It may not be possible to hear appeals received after this date prior to the start of the new term in September 2024.
- Please note no appeals will be heard between Monday 22 July 2024 and Tuesday 14 September 2024.

## **Appeals process**

- Your appeal will be acknowledged by letter and email within 5 school days of receipt. If you do not receive an acknowledgement within a week of lodging your appeal, contact Warwickshire County Council on 0845 155 1793 as a matter of urgency.
- Notification of the appeal(s) date will be sent out by letter and email at least 10 calendar days before the hearing.
- Confirmation of the hearing details and the papers relating to your appeal will be sent out to all parties at least 7 calendar days before the appeal.
- Warwickshire County Council must receive any additional supporting documents at least 7 calendar days before the first day of the hearing for the school you are appealing for, irrespective of where you are listed within that hearing. Unfortunately they will not be able to accept additional information after this date.
- The appeal panel will decide whether or not material submitted after this deadline will be considered, taking into account the amount and its significance and the effect of a possible need to adjourn the hearing. Therefore we strongly advise you to comply with this deadline.
- The Independent Appeals Panel's decision will be sent to you by email within 5 calendar days of the hearing, where possible.
